The quoted rate should be reasonable, logical, and convincing. Mere quoting the lowest service charge which is not reasonable will not give any right to the agency for being selected.

If there is any difficulty in the selection of the lowest bidder on the basis of minimum service charge then selection will be made as per the Technical Qualification of the bidder (Work Experience, Yearly Turn Over and Man Power will be taken into priority) for final selection of the bidder.

TERMS & CONDITIONS

- 1. The accepting authority reserves the right to reject any or all the quotations without assigning any reasons thereof.
- 2. The participating bidders are required to quote their rate in per head per day both in figure and words.
- 3. The charges to be paid to Security Agency are to be shown in two parts- a) Security charges, b) Service charges. Security Charges is the minimum wages (as per the latest order of the Department of Labour, Govt. of W.B.) of the security personal plus charges for ESI, EPF and Bonus (as per latest Govt. approved rates). The bidders have to quote service charges only in the corresponding BOQ file.
- 4. The responsibility of deposition of contribution for ESI, EPFetc. is to be borne by the security agency.
- 5. The service charge must include all other incidental charges. No bidder could charge "zero price or nearly equal to Zero price" as service charge, if so then the bidder concerned will not be considered as a valid participant in the concerned tenderprocess.
- 6. Security charges are to be quoted as per latest Govt. order, there will be no variation in security charges. Hence, lowest quotation will be selected as per rates quoted for service chargesonly.
- 7. The period of contract will be from 01.04.2022 to 31.03.2023 and no enhancement of service charge is admissible during this period. However, security charge may vary time to time and will be paid as per the latest Govt. notification.
- 8. No conditional / incomplete rate will be accepted under any circumstances. Quotation without proper documents will berejected
- 9. The agency engaged for this work will have to maintain a regular contact with the collegeauthority.
- 10. The persons engaged for the duty will have to wear same uniform and identity card for identification. Uniforms will have to be supplied by the selected agency/firm for which no additional allowance or charges will be entertained.
- 11. The duty hour will be 8 (eight) hours for each Security Personnel and will be fixed by the Collegeauthority.
- 12. The College authority shall not be responsible to supply rain coat / umbrella, Torch / oil etc. if required. The same are to be supplied by theselected agency.
- 13. The College authority shall not be responsible to compensate or otherwise liable in any manner what so ever for an injury and for death of Security Guards while onduty.
- 14. No claim will be entertained for the permanent services of the guardsengaged.
- 15. T.A., D.A., Overtime allowance will not be paid to the security guards by the collegeauthority.
- 16. Immediately after receiving the work order, the agency must submit to the College authority list showing the Name, Signature (L.T.I), Passport size photograph, Election Photo Identity Card (EPIC) in duplicate of each security guard deployed duly self-attested well in time. If any change is made subsequently by the agency, the change(in name, signature etc.) is also to be intimated to the College authority as and when such change is made. The agency will be fully responsible for any losses, shortages, damages, of Govt. property and the cost of the same as fixed by the authority will be recovered from bills of the agency.

- 17. The agency will keep itself ready to take up the work within seven (7) days from the date of issue of work order or from any other special date as will be mentioned.
- 18. The agency will not be entitled to withdraw the agreement without serving a notice of withdrawal to the authority prior to 3 months.
- 19. The undersigned reserves the right to terminate the agreement at any time without assigning any reason what
- 20. a) Bill in triplicate on monthly basis as per format given in Annexure-I must be submitted within 10th of the next month.
- b) Payment to the agency shall be made as per availability of fund from Higher Education Department, Govt. of West Bengal and through IFMS portal and Krishnagar Treasury-I.
 - c) Statutory deduction as applicable shall be made from the bill of the agency.
- d) This college being a part of Government vacation Department, College remains closed for certain periods of time during the calendar year but security service will continue and if it is observed/reported that security personnel are not attending their duties, the owner of the agency will be asked to report immediately by the college authority to go to college and look into the matter as security of the college cannot be compromised. - The security personnel may be placed anywhere within the jurisdiction of GOVT, GENERAL DEGREE COLLEGE, CHAPRA for security related duties.
