NOTIFICATION

Consequent upon the Order No – 753/XVII – ISS/2M -22/2020 dated 02.01.2022 issued by the Chief Secretary, Government of West Bengal and notification issued by the Department of Higher Education vide Memo No.01-Pr-Secy-HED/2022 Dated 03/01/2022 in connection with present situation of COVID 19 pandemic and high rate of infectivity and multiple cases of new COVID 19 variant "Omicron" all concerned (Teachers, Officers, Non-teaching staff, Research Scholars and Students) are hereby requested to kindly note the following and act accordingly.

1. All off-line academic activities including practical classes shall remain closed.
2. However, online classes, online examinations (if any), online submission of application form and other online activities of this University and the colleges affiliated to this university shall continue as per schedule.
3. Administrative Departments/ Sections (Vice Chancellor's Secretariat, Pro-Vice-Chancellor's Secretariat, Dean's Office, Registrar's Department, Department of Finance, Department of Controller of Examinations, Works Department, Office of the DSW, Office of the Inspector of Colleges, Office of the Secretary Faculty Councils PG & UG, Office of CIRM, Central Library) and Administrative activities of the Academic Departments/ Centres will be functional with 50 percent of the employees under the supervision of the Head of the concerned Department/ Section/ Centre.
4. University Health Centre shall remain open and operational with the Medical Officer, and other support staff of the Health Centre.
5. All emergency and essential services [Security, Electricity, Water Supply, and Sweeping] shall continue as before.
6. The Hostels will also remain closed until further order. Adequate arrangements as per the medical protocol will be provided for foreign/ other students who are not able to leave the campus due to distance or otherwise. No visitor should be allowed during the period to visit the hostel, without prior approval of the Head of the Institute.
7. All concerned will have to follow strictly personal protective norms (use of mask, hand sanitization, maintenance of physical distancing) during office hour.

This Notification will be made effective immediately and shall remain valid till 15.01.2022.
